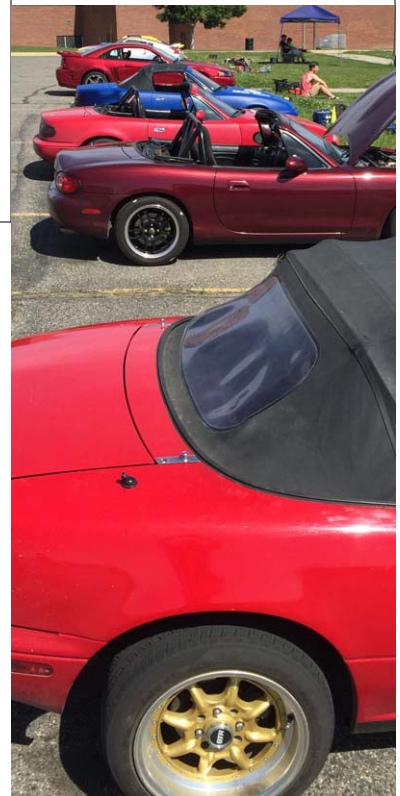

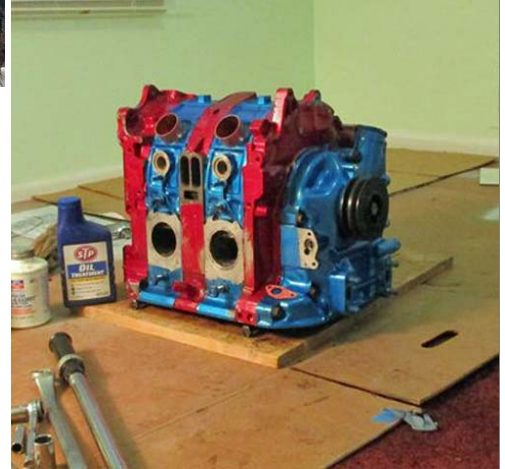


## MyT13B's Corner — From the Regional Executive



I am excited to be the R.E. for the coming year. However, I still plan to be “yours for the sport” in most aspects of our events. As I presume you have heard, I have been resurrecting my “project car,” Stage IV of the (over) 20-year-old project. Major revisions include a near mid-engine placement and a modified 1980 RX7 body that will tilt (with a lot of effort). Suspension geometry and brake system have been improved. The engine is a 1974 13B rotary that has been modified for internal strength and

reliability. (See photo at right) I expect around 225-250HP at 4000 rpm and peak around 400HP at 8000 rpm. It will sound mild-mannered with a smooth idle. The car should weigh close to 1800 pounds with driver. The front/rear balance is about 55% rear-biased. I have chosen Hoosier A7 tires that fit 13 x 10 wheels in front and 13 x 11 wheels in the back.
