Meeting Minutes—January Meeting

The monthly membership meeting of the Yellowstone Region SCCA was called to order by Regional Executive Chris Brewer on Tuesday, January 8, 2013, at 6:00 p.m., in the GH&R Law Firm conference room.

Minutes of Previous Meeting: A motion was MS&P to accept without addition or correction the minutes of the December 2013 meeting as published in the January-February issue of Fast Times.

Treasurer's Report: Secretary/Treasurer J. Reuss reported the current checkbook balance and noted that all bills were current. J. also presented a recap of expenses related to the timing trailer refurbishing and a recap of Region income and expenses for 2012.

Old Business: After some discussion, it was decided to keep entry fees the same for 2013. J. reported that he had contacted RaceAmerica to determine if the timing display settings could be "kicked up a notch." RaceAmerica recommended that the Region consider the purchase of a new display. Doug suggested that we try boosting power to the display by adding an additional battery (or two).

New Business: New member Stewart Tucker will be the Chief of Tech this year and will also be in charge of the Region's Facebook page. Former Chief of Tech, Dean Johnson, will assist Stewart with the transition. Midwinter Musings - by the Roving Regional Reporter

Regular readers of *Fast Times* will recall mention of the problematic track surface at Maui SCCA's regular event site. The paving at the former WWII airbase had seen better days. The surface is extremely tough on tires and the number of runs taken by entrants is usually limited by how much rubber you wanted (or could afford) to lose. Asphalt paving—or more accurately paving made of asphalt concrete—is made of asphalt, a heavy tar that serves as a binder, and mineral aggregate. In North America, the

mineral aggregate is typically crushed rock. In Hawaii, aggregate is primarily crushed volcanic rock and/or sea shells. Asphalt paving deteriorates when the sun and elements break down the tar, exposing more of the aggregate. Deciding to take matters into their own hands, resourceful members rented a truck to apply sealer and solicited donations to purchase sealing material. Photos of the results are on page 2. The first event for the \$300 Civic was at Skyview in May of 2006. Although the car had a (slightly) upgraded motor in the form of an Acura D16A1, it was rated at only 16HP more than the stock D15B2's 102HP. I promised the team that we would upgrade the motor after handling and reliability issues were sorted. I am pleased to report that after 7 seasons, the only "casualties" have been three sets of tires, an alternator, and a battery. (I only changed the oil once during that time frame, but the car hasn't seen any-

where near the recommended 3,000 miles between oil changes!) Considering that the car is double-stinted at most events, that is a lot to say for Honda reliability. Anyway, I finally broke down and purchased a another motor—an Acura K24. The K24 is rated at just over 200HP in stock form, but ace mechanic Dennis McCollough will likely increase that number before he is finished. To get all that power to the pavement, Max Dangerfield has provided guidance for wheel and tire upgrades. Stay tuned! J.
