Meeting Minutes:

Yellowstone Region 108 - May Meeting

The monthly membership meeting of the Yellowstone Region SCCA was called to order by Regional Executive Scott Cranston on May 7, 2008, at 6:37 p.m., at the GH&R Law Firm conference room.

Minutes of Previous Meeting: A motion was MS&P to accept without addition or correction the minutes of the April 2008 meeting as published in the May 2008 edition of *Fast Times*.

Treasurer's Report: Secretary/Treasurer Mark Richlen reported that the current balance of the club's checking account was approximately \$3,563.85. Richlen also reported that he had recently paid BCS for porta-potty rental and that there were a few other bills to pay, but they were all current. Cranston handed over receipts from the recent event at FSA.

Old Business: Poster Project: It was generally agreed to continue refining the poster project. An additional \$50 was authorized to make additional color copies. It was suggested that smaller (8-1/2" x 5-1/2") posters be prepared to distribute at the upcoming car show and to hand out at other events. Members could also be given copies to hand out to interested persons. Richlen reported that a club banner had been ordered and that helmet stickers, rulebooks and wristbands had been ordered. Richlen indicated he would look into obtaining Weekend Membership forms and/or combined Weekend Membership and entry forms. It was decided that we would feature Cranston's teal 'Stang, Reuss' Civic and Gilliland's Avenger at the Rimrock Auto Show on June 14th (unless Gilliland is at a hillclimb and/or another member wants to show his or her car off.)

New Business: The possibility of implementing a point system for solo finishes was discussed. It was decided to look into the system being used by Bozeman and discuss the issue further at a later time. Everyone who was at the FSA event reported it went well. Some items to be smoothed out were: specific information and proper membership applications for SCCA membership; a written script to be used at driver's meeting to assure all information is provided; assigning a worker for wristband duty during run groups. It was also agreed that drivers should be reminded that it was their obligation to make sure their guests had signed waivers and obtained wristbands. It was also discussed that a worker would be assigned during each run group to put run times on a scoreboard in "real time" as they were announced by the timer (including penalties). Entry forms would also be revised to clarify that it is the drivers' responsibility to know what class their car belongs.

A motion was MS&P to adjourn the meeting at approximately 7:22 p.m.

Wanted—Secretary/Treasurer

Those folks who check the Region website from time-to-time have noted that long-time club member and long-time Region Secretary/Treasurer Mark Richlen has recently resigned his post. In offering his resignation, Mark noted that "it was time for one of the newer members to take on the responsibility." Mark's tireless contributions to the Region are greatly appreciated and we will miss the institutional memory that he offered. Car Classes Revisited

For the past few years, the Region has become somewhat lax when it comes to car classes at events. Solo car classification is not a priority at smaller events when everyone is just "out for a good time." However, car classification is a serious business at larger events such as regionals and divisionals. Car classification is the responsibility of the entrant. Designating the proper class of your car on an entry form is somewhat on the "honor system." That is, unless someone protests the class an entrant has designated, no one is the wiser. Classifying stock (or nearly stock) vehicles is relatively easy. The SCCA National Solo Rule-

book—available either online or at an event—contains basic classification information. Stock classes allow a minimal number of "allowances" before a vehicle is relegated to a "modified" or "prepared class."

Several regions and have posted car classification worksheets on websites. In the next few days, links to these websites will be added the Region Website to help entrants "fine tune" their classification. However, keep in mind that the SCCA National Solo Rules are the "final word" when it comes to classification. Classification worksheets should only be used as a starting point to determine where your car truly belongs.
