## Meeting Minutes—August Meeting

**Minutes of Previous Meeting:** A motion was MS&P to accept without addition or correction the minutes of the July 2011 meeting as published in the August 2011 issue of *Fast Times* (the Newsletter Editor apologized for getting it out at the last minute).

**Treasurer's Report:** Sec./Treas. J. Reuss announced the current bank balance. J. reported that after cutting a check prior to the meeting to Competition Chairman Randal Roberts for the new loaner helmets, all outstanding bills had been paid. J. noted that the profit from Skyview pretty much cancelled out the loss from YDS. A Motion was MS&P to accept the Treasurer's Report.

**Old Business:** Chief of Timing Doug Hills and Chief of Registration J. Reuss reported that they have resolved the networking issues with the timing and scoring software. The person doing registration can now register entrants while an event is in progress, so it was agreed that a registration cut-off time is no longer necessary. It was also agreed that tech inspection of late entrants would not be a problem and that in lieu of a walk-thru, late registrants could ride with another entrant. However, late registrants would not have a right to make-up runs. A discussion was held about the positive social interaction that occurred between members and new(er) entrants at the Skyview event.

**New Business:** Chris reported that he had heard from Member Al Merkel who reported that he intended to run a full season in 2012. A discussion was held regarding the upcoming 2-day event at GM Petroleum and chores were assigned.

A motion was MS&P to adjourn the meeting at approximately 6:33 p.m.


