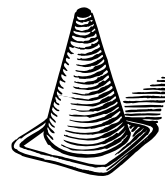

Meeting Minutes — May Meeting

The monthly membership meeting of the Yellowstone Region SCCA was called to order by Regional Executive Scott Cranston on May 6, 2009, at 6:30 p.m., in the GH&R Law Firm conference room.

Minutes of Previous Meeting: A motion was MS&P to accept without addition or correction the minutes of the April 2009 meeting as published in the May 2009 issue of *Fast Times*.

Treasurer's Report: Sec./Treas. J. Reuss announced the current bank balance and reported that the first two events of the season made money despite less-than-usual attendance. A Motion was MS&P to accept the Treasurer's Report.

Old Business: J. was asked to order extra SCCA helmet stickers to use for tech inspection. Reese Newman volunteered to design and prepare business cards for Region use. J. will contact SCCA to obtain official SCCA artwork. A motion was MS&P to authorize Reese to obtain and distribute copies of 2009 Region posters. J. reported that the laptop purchase was the next item on his to-do list.

New Business: Scott asked J. to contact the Corvette folks to determine: (1) whether the speed bumps at Skyview will be a problem; (2) whether the insurance has identified Skyview as a named insured; and (3) whether we need to prepare a tech inspection form for the event. Scott will purchase a new (weatherproof) table for the timing trailer. Everyone was reminded of the upcoming Lewistown event and a discussion regarding the Great Falls Porsche Club website (containing extensive Lewistown information) followed.

A motion was MS&P to adjourn the meeting at approximately 7:10 p.m.

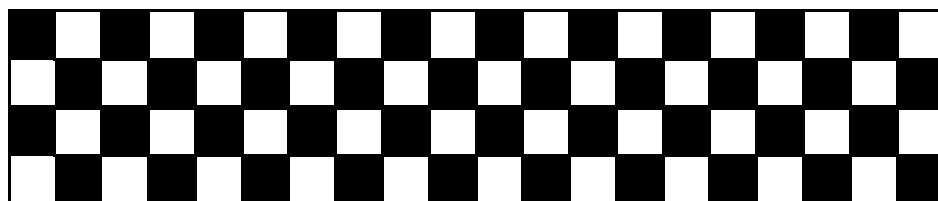
